

Brie Schmidt, Relationship Coach - Email Coaching, 1 month package

This Email Coaching Contract states the terms and conditions that govern the contractual agreement between Brie Schmidt (“Coach”), and the “Client” who agrees to be bound by this Agreement.

WHEREAS, the Coach offers services in the field of Relationship Coaching; and

WHEREAS, the Client desires to retain the services of the Coach to render coaching services with regard to Relationship Coaching according to the terms and conditions herein.

NOW, THEREFORE, In consideration of the mutual covenants and promises made by the parties hereto, the Coach and the Client (individually, each a “Party” and collectively, the “Parties”) covenant and agree as follows:

1. Term

This Agreement shall begin at the time of purchase and will last for one month as determined by the purchase date. For example, if a purchase is made on January 1, it will expire on February 1. If a purchase is made on June 15, it will expire on July 15. The date of purchase is determined by the time zone in which the Coach is located.

- 1 In the event that the Client cannot complete the contract for this full term, refunds will not be given.
- 2 If the Coach is unable to perform duties for the full month, such as the result of emergency or other unexpected events, refunds will be prorated for the period at which services could not be rendered.

2. Coaching Services

The Coach agrees that she shall provide her expertise to the Client for all things pertaining to Relationship Coaching (the Coaching Services). These services will be carried out in email only. The Coach will respond to emails within 24 hours during weekdays (determined by the time zone and location in which the Coach is located), and within 48 hours on weekends (determined by the time zone and location in which the Coach is located). The Coach promises to respond in a timely manner, often before this 24 or 48-hour period. If this period cannot be honored due to emergency or other unexpected events, the Coach will promptly notify the Client.

3. Role of the Client

The Client will play an active role in the coaching process in order to achieve desired results. The Client is to retain full responsibility for their own actions, decisions, and wellbeing, and agrees that the Coach is not liable for any action or inaction, or any direct or indirect result, of the coaching process. The Client agrees

that the Coaching Services are not a replacement for therapy or medical help.

The Client also agrees to remain professional, even while sharing personal information related to relationships, dating, etc. If the Coach experiences harassment, including but not limited to sexual harassment, the Coaching Contract and Services will be terminated without refund.

4. Payment & Compensation

In consideration for the Coaching Services, the Client shall pay the Coach at the rate of 98USD per month unless otherwise noted. Cost may change based on exchange rates or at the Coach's discretion. This compensation will begin the contract and service period. To continue services beyond one month, the Client must make a new payment. Payment is made online at brieschmidt.com via Stripe.

5. Intellectual Property Rights

The Client acknowledges and agrees that the Coach will hold all intellectual property rights in the resources shared during the Coaching Services. The Client must not share, reproduce, or sell the personal exchanges and downloadable property provided during the Coaching Services.

6. Confidentiality & Privacy

The Coach shall not disclose to any third party any details regarding the Client's personal and identifying information, unless in the event of medical emergency or crisis (see 7. *Mental Health Responsibility*). In the event that the Coach must keep records of coaching emails and other personal information, it will be stored privately. The Client should be aware that email and digital correspondence could be accessed by a third party ("hacker"), but the Coach will maintain security to the best of her ability.

7. Mental Health Responsibility

The Coach is not responsible for diagnosing or treating mental health concerns. Relationship Coaching provided by Brie Schmidt is not the same as therapy or mental health counselling. The Coach may recommend services from a mental health professional to Clients when she deems necessary. In case of medical emergency or crisis, the Coach may notify emergency services.

8. No Modification Unless in Writing

No modification of this Agreement shall be valid unless in writing and agreed upon by both Parties. If the Client experiences problems, they can be discussed through email, and the Coach will make adjustments if possible.

9. Acknowledgment of Coaching Contract

In lieu of a signature, the purchase of Email Coaching or other Coaching Services is regarded as acknowledgment and agreement of the Coaching Contract. If you have questions or concerns, please email contact@brieschmidt.com.
